- \$175 for Full Membership which also includes your Full Membership subscriptions.

FLEXIBLE PAYMENT OPTIONS

1) 5 YEAR MONTHLY DIRECT DEBIT PAYMENT OPTION

CATEGORY	Monthly Fee until June 30 2011	Facilities Fees
FULL	\$175	\$70
6 DAY	\$155	\$70

Conditions

- Monthly Fee includes the Entrance Fee charged over a 5 year period, the Annual Subscription for the current membership year and administrative charges.
- Until the Entrance Fee is paid off, i.e. 5 years from date of acceptance to membership, the member receives no voting rights.
- After 5 years, once the Entrance Fee is considered paid, the monthly fee to cover the Annual Subscription portion until the end of that membership year at which time payment options for Annual Subscriptions for the following year as offered to all members will be available.
- The annual subscription portion within the Monthly Fee is to be adjusted on July 1 2011 and thereafter in July each year when Annual Subscriptions are adjusted by the Board. Please note this applies to the Annual Subscription portion only and generally is around the CPI level.
- Facilities Fees are payable upon acceptance into membership and to be paid by June 30 each year for the following year.
- From July 1 2011, the direct debit process will administered through a third party.

2) 5 YEAR ENTRANCE FEE PAYMENT PLAN OPTION

CATEGORY	Entrance Fee Charged per Year	Current Annual Subscriptions	Facilities Fees
FULL	\$500	\$1430	\$70
6 DAY	\$440	\$1240	\$70

Conditions

- Entrance Fee payment is fixed at \$500 each year for Full member and \$440 each year for 6 Day Members for the 5 year period.
- For members joining within the membership year, the first Entrance Fee installment is due upon enrolment with the second installment due by June 30 for the following membership year.
- Until the Entrance Fee is paid off, the member receives no voting rights.
- Annual Subscriptions are charged on a pro rata basis from the date of commencement of membership until June 30 2011 at which time the Annual Subscriptions for the membership year July 1 2011 to June 30 2012 are due. Note Annual Subscriptions are adjusted by the Board in July of each year.
- Facilities Fees are payable upon acceptance into membership and to be paid by June 30 each year for the following year.

3) 6 MONTHLY PAYMENT OF ANNUAL SUBSCRIPTIONS

Conditions

- Available from July 1 2011.
- Annual Subscriptions are paid for each 6 month period of the year as follows;
 - 50% of the Annual Subscription and an \$30 Administration Fee payable by June 30 2011
 - Remaining 50% of Annual Subscription payable by December 31 2011.
- Members on this program receive full voting rights if their Entrance Fee has been fully paid.
- Facilities Fees are payable upon acceptance into membership and to be paid by June 30 each year for the following year.
